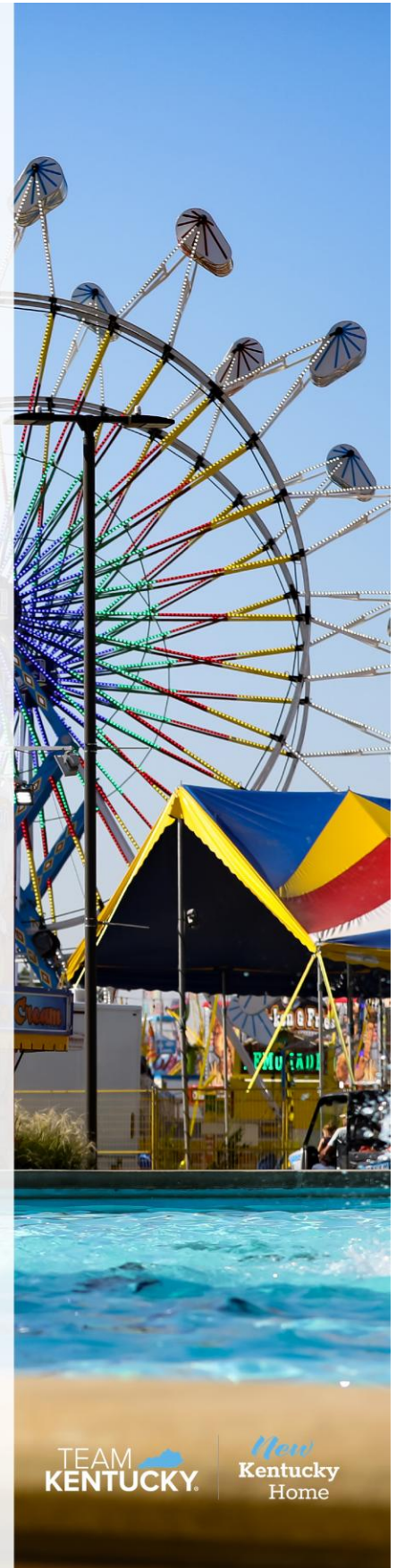

GENERAL RULES AND REGULATIONS OF THE FAIR

THESE RULES WILL BE STRICTLY ENFORCED

ENTRY OF EXHIBITS

1. All entries shall be made on printed forms furnished by the Kentucky State Fair. The forms are available by writing to the Entry Department, Kentucky State Fair, PO Box 37130, Louisville, KY 40233. Print or use a computer if possible and supply all the information requested. Entries will not be accepted unless accompanied by the required entry fees.
2. Entries close on dates specified in each department. No entries will be accepted after that date.
3. Exhibitors' gate admission tickets may be purchased by Horse Show exhibitors at the Horse Show Office, and for all other exhibitors at the Entry Department. Exhibitors will be limited to the purchase of two (2) exhibitor gate admission ticket packets except when the care of livestock or horses is required.
4. No employee of the Kentucky State Fair can own or exhibit any articles or animals in any competition in which said employee is directly affiliated.
5. Every animal or article in competition will be under the supervision of the Superintendent of the department in which it is entered, but the Kentucky State Fair Board and Management will not be responsible for any loss or damage that may occur.
6. Exhibits that have been mistakenly entered into a class may be transferred to the proper class before judging at the discretion of the Superintendent. If such classes already have been judged, they will not be reopened.
7. The Superintendent of each department must check entries listed under each class in the entry book against each exhibit presented. At the time of judging, he or she shall mark the entry book to show which animals or articles were passed on by the judge.
8. Judging books shall be signed in ink. Entries that were not shown should be so designated. Superintendents are responsible for these requirements.

PLACING OF ENTRIES

1. The Kentucky Exposition Center will be open to receive livestock and articles for exhibition at dates and times specified in departmental rules. No livestock or articles may be brought into the Kentucky Exposition Center and placed on exhibit except by and at the expense of the owner or his/her authorized agent.
2. Articles from outside Louisville and vicinity may be mailed to the name of the department entered, c/o Entry Department, Kentucky State Fair, 937 Phillips Lane, Louisville, KY 40209. Packages will not be accepted by the State Fair unless all charges have been paid.
3. All animals or articles for exhibition shall be placed in the department before the time listed in departmental rules. If not placed before the specified time, the owner will forfeit all rights to exhibit or compete for premiums subject to appeal to the Kentucky State Fair Board.

RELEASES

1. Exhibitors shall obtain signed releases from the Superintendent of their department.
2. See departmental rules for times of release. No animals or articles will be released before the published release date and time.

NATIONAL CODE OF SHOW RING ETHICS

Exhibitors of animals at livestock shows shall always conduct themselves with honesty and good sportsmanship. Their conduct in this competitive environment shall always reflect the highest standards of honor and dignity to promote the advancement of agricultural education. This code applies to junior as well as open class exhibitors who compete in structured competition classes. This code applies to all livestock offered in any event at a livestock show.

All youth leaders working with junior exhibitors are under an affirmative responsibility to do more than avoid improper conduct or questionable acts. Their moral values must be so certain and positive that those younger and more pliable will be influenced by their fine example. Owners, exhibitors, fitters, trainers, and responsible persons who violate the code of ethics will forfeit premiums, awards, and auction proceeds and shall be prohibited from future exhibitions in accordance with the rules adopted by the Kentucky State Fair. Exhibitors who violate this code of ethics demean the integrity of all livestock exhibitors and should be prohibited from competition at all livestock shows in the United States and Canada.

The following is a list of guidelines for all exhibitors and all livestock in competitive events:

1. All exhibitors shall present at the request of fair and livestock show officials, proof of ownership, length of ownership, and age of all animals entered. Misrepresentation of ownership, age, or any facts relating thereto is prohibited.
2. Owners, exhibitors, fitters, trainers, or responsible persons shall provide animal health certificates from licensed veterinarians upon request by fair or livestock show officials.
3. Junior exhibitors are expected to care for and groom their animals while at fairs or livestock shows.
4. Animals shall be presented to show events where they will enter the food chain free of violative drug residues. The act of entering an animal in a livestock show is the giving of consent by the owner, exhibitor, fitter, trainer, and/or person responsible for show management to obtain any specimens of urine, saliva, blood, or other substances from the animal to be used in testing. Animals not entered in an event that culminates with the animal entering the food chain shall not be administered drugs other than in accordance with applicable federal, state, and provincial statutes, regulations, and rules. Livestock shall not be exhibited if the drugs administered in accordance with federal, state, and provincial statutes, regulations, and rules affect the animal's performance or appearance at the event. If the laboratory report on the analysis of saliva, urine, blood, or other sample taken from livestock indicates the presence of forbidden drugs or medication, this shall be prima facie evidence that such substance has been administered to the animal either internally or externally. It is presumed that the sample of urine, saliva, blood, or other substance tested by the laboratory to which it is sent is the one taken from the animal in question, its integrity is preserved, and all procedure of said collection and preservation, transfer to the laboratory, and analysis of the sample are correct and accurate, and the report received from the laboratory pertains to the sample taken from the animal in question and correctly reflects the condition of the animal at the time the sample was taken, with the burden on the owner, exhibitor, fitter, trainer, or absolutely responsible person to prove otherwise. At any time after an animal arrives on the fair or livestock show premises, all treatments involving the use of drugs and/or medications for the sole purpose of protecting the health of the animal shall be administered by a licensed veterinarian.
5. Any surgical procedure or injection of any foreign substance or drug or the external application of any substance (irritant, counterirritant, or similar substance) that could affect the animal's performance or alter its natural contour, confirmation, or appearance, except external applications of substances to the hoofs or horns of animals, which affect appearance only and except for surgical procedures performed by a duly licensed veterinarian for the sole purpose of protecting the health of the animal, is prohibited.
6. The use of showing and/or handling practices or devices, such as striking animals to cause swelling, using electrical contrivance, or other similar practice is not acceptable and is prohibited.
7. Direct criticism or interference with the judge, fair or livestock show management, other exhibitors, breed representatives, or show officials before, during, or after the competitive event is prohibited. In the furtherance of their official duty, all judges, fair and livestock show management, or other show officials shall be treated with courtesy, cooperation, and respect, and no person shall direct abusive or threatening conduct toward them.

8. No owner, exhibitor, fitter, trainer, or responsible person shall conspire with another person or persons to intentionally violate this code of ethics or knowingly contribute or cooperate with another person or persons either by affirmative action or inaction to violate this code of ethics. Violation of this rule shall subject such an individual to disciplinary action.
9. The application of this code of ethics provides for absolute responsibility for an animal's condition by an owner, exhibitor, fitter, trainer, or participant whether he or she was instrumental in or had actual knowledge of the treatment of the animal in contravention of this code of ethics.
10. The act of entering an animal is the giving of consent by the owner, exhibitor, fitter, trainer, or responsible person to have disciplinary action taken by the fair or livestock show for violation of this Code of Show Ring Ethics and any other rules of competition of the fair or livestock show without recourse against the fair or livestock show. The act of entering an animal is the giving of consent that any proceedings or disciplinary action taken by the fair or livestock show may be published with the name of the violator or violators in any publication of the International Association of Fairs and Expositions, including Fairs and Expositions and any special notices to members.
11. The act of entering an animal in a fair or livestock show is the giving of verification by the owner, exhibitor, fitter, trainer, or responsible person that he or she has read the IAFE National Code of Show Ring Ethics and understands the consequences of and penalties provided for actions prohibited by the code. It is further a consent that any action which contravenes these rules and is also in violation of federal, state, or provincial statutes, regulations, or rules may be released to appropriate law enforcement authorities with jurisdiction over such infractions.

OFFICIAL VETERINARIAN

If Veterinarian services are needed, the owner may contact the veterinarian, Dr. Seth Sadler, in the veterinarian's office located in Broadbent Arena. The owner may use any vet they desire in the care of their animals, and the owner is responsible for fees charged for these services. Call (859) 707-8600.

DUTIES AND PRIVILEGES OF EXHIBITORS

Exhibitors should always care for their exhibits. At the close of the Fair, exhibitors must assume responsibility for them.

Kentucky State Fair Animal Health Requirements for Equine, Including Mules:

All equines must have a valid CVI (Health Paper) and a Form VS10-11, or an EIA test form verifying negative EIA from a laboratory approved by the USDA, within the past twelve (12) months. For additional testing or requirements due to a reportable disease outbreak contact Kentucky Department of Agriculture, Office of the State Veterinarian (502) 573-0282

DISCOURTESY TO JUDGES AND OFFICIALS

The Manager or Superintendent of any department will have the authority, without liability or recourse to the Kentucky State Fair Board, to bar any exhibitor, or his/her representatives, in the event of discourteous act to a judge or an official of the Fair, and he/she will have power to disqualify the entry of that exhibitor. In the event of such disqualification, the exhibitor forfeits all fees paid as well as any prize money won.

PROTESTS

1. All protests shall be made in writing, plainly stating the reason for the complaint or appeal, and shall be filed with the management of the Kentucky State Fair Board. All protests must be accompanied by a \$500.00 cash deposit, which will be forfeited if the protest is not sustained.
2. Protests against the exhibition of animals or articles shall be filed at least 24 hours before the awards are made. Protests awards shall be filed for protests by 8:00 p.m. on the day on which the awards are held, or, in the case of articles judged prior to the opening of the Fair, by 8:00 p.m. on the official opening day of the Fair.
3. All protests will be considered at a time set by the Kentucky State Fair Board, and the interested parties will be notified and given the opportunity to submit evidence.
4. In addition to the right of protest herein guaranteed to interested parties, the Kentucky State Fair Board expressly reserves the right to take cognizance of fraud, which may have been consummated or attempted, and to take such action as may be deemed just and proper.

NO LIABILITY

1. Every possible protection and courtesy will be extended to exhibitors at the Kentucky State Fair, but the Board shall not be responsible for any loss of exhibits, animals, or equipment in case of fire, theft, or loss from any other cause.
2. The Kentucky State Fair Board, its agents, servants, and employees shall not be held liable in case of injury to exhibitors, concessionaires, or the public on the grounds or in the buildings from any cause whatsoever while on the grounds of the Kentucky State Fair.
3. All equipment regardless of source of power shall comply with all national, state, and local safety codes. All exhibitors' cords shall be the 3-wire grounded type. All exposed noncurrent-carrying metal parts of fixed equipment, which are liable to be energized, will be grounded.

AWARDS

1. Competent judges selected from lists suggested by exhibitors and Breed Associations have been invited to judge and have accepted, but in case of their inability to serve, the Management reserves the right to select another judge, or judges, to fill the vacancy. No refunds of entry fees, stall rent, etc. will be made in any department due to the replacement of a judge.
2. Judges will report to the Superintendents in charge at their respective departments according to times and dates specified in the contract.
3. An exhibitor cannot (a) act as judge in a class in which said exhibitor is showing or (b) exhibit an entry in any class where the judge is a principal agent, employee, or relative of the exhibitor.
4. Where there is only one entry in a class, the first prize will be awarded if merited. If an exhibit is not worthy of first prize, judges may, at their discretion, award the prize that the animal or article deserves.
5. Should any doubt arise as to the regularity of any entry, or any other important matter, which the judge feels incompetent to decide, he/she should notify the Superintendent, Board Member in Charge of Department, or Management, whose decision will be final.
6. The decision of an awarding judge will be final, and no appeal will be considered except in case of protest.
7. Objections to any person serving as a judge shall be submitted to the Kentucky State Fair Board in writing, prior to making an award, giving good and sufficient reason therefore, and upon which the Board shall have full power to act.
8. Any exhibitor attempting to interfere with the judges during their adjudications will be promptly excluded from

competition.

9. Each Superintendent in charge should carefully maintain the judging books of the department, since the judging books are the only basis for the payment of premiums.

PREMIUMS

1. Premiums will be paid by the Kentucky State Fair as early as possible after the awards in the various departments have been made and checked.
2. Premiums will be paid by the check sent by the Kentucky State Fair to the post office address of the exhibitor.
3. Errors in premium statement will be corrected until November 1, following the Fair after which time the books are closed, and unpaid premiums are forfeited to the Fair.
4. Any premium check not cashed within 90 days following the date of issue will be forfeited to the Fair. No exceptions will be made.
5. The Kentucky State Fair Board will list in good faith special premiums and awards in the premium list but is not responsible for their payment and delivery.
6. The following colors of ribbons will be used to designate awards in all departments except Horse Show and Plants and Flowers:

First premium Blue
Second premium..... Red
Third premium White
Fourth premium..... Pink
Fifth premium Yellow
Sixth and additional premiums Green

Championships Royal Purple Rosette
Grand Championships Royal Purple Banner

7. Ribbons have no value for payment of premiums, as premiums are paid only from the record of the judging books.

STALLS

1. Stalls will be assigned only to bona fide exhibitors. Exhibitors subletting stalls without permission from the Superintendent of the Department will forfeit their stalls, and stalls will be subject to reassignment.
2. Unless an animal is entered into the Livestock Department, it may not occupy a stall or pen until all exhibition animals are accommodated. Space for tack and display is subject to availability. No refunds of fees will be made.
3. Exhibitors not arriving by the designated time will forfeit fees paid, and reserved stalls will be subject to reassignment. In case of our failure to attend the Fair, proper notification should be given to the Fair Office.
4. ***The State Fire Marshall requires 2A10BC fire extinguishers and smoke detectors for all stalls used as living quarters during the World's Championship Horse Show.***

THERE ARE NO REFUNDS OF ENTRY FEES

OPERATION OF VEHICLES

The speed limit within the Fairgrounds is 25 miles per hour, and it is strictly enforced. In addition, there are fire lanes which must be always clear, no parking areas, areas in which vehicular traffic is prohibited, and other traffic and vehicle control regulations. State statute provides fines for violation of any traffic control regulations established by the Kentucky State Fair Board.

ELECTRIC LIGHTS AND POWER

Charges for electricity and wiring will be made to exhibitors and concessionaires according to the schedule on file in the office of the Manager of the Fair and will be furnished upon request by the official Kentucky State Fair electrician.

PERMITS AND PRIVILEGES

1. Each concessionaire will limit himself/herself to the space assigned to him/her. Failure to do so will subject him/himself to the forfeiture of this privilege, without recourse.
2. Under no circumstances will any person or firm be allowed to place any advertising matter upon buildings, trees, or any place on the grounds, nor will they be permitted to distribute advertising matters outside of the place assigned to them.
3. Purchasers of concessions shall keep their spaces in clean and sanitary condition and meet all requirements of the State Board of Health.
4. The Board reserves the right to declare any concession objectionable, either in character, manner, or operation, or because of location, in which event the operation of the concession shall be stopped, and the contract cancelled without recourse.

ENTERING THE GROUNDS

All exhibitors bringing horses onto the grounds should use Gate 6 located off Preston Highway. Any vehicle bringing horses or livestock to the Fair which is to remain on the ground throughout the Fair period shall be parked in areas designated by the Superintendent of his/her department.

RECREATIONAL VEHICLES

A limited amount of RV parking will be available at a charge of \$62.00 per day, cash, or credit card payment (Visa, MasterCard, Discover & American Express) only; however, there are no hookups or dumping facilities. Space will be assigned on a first-come, first-served basis, and no space can be guaranteed. Venue Services is located at the administration offices in front of Freedom Hall or call (502) 367-5384. Any RVs driven at the Kentucky Exposition Center will be subject to RV charges.

ACCESSIBILITY SERVICES

This document is available in PDF, or sections will be read to the visually impaired by Kentucky State Fair Staff.

The Kentucky Exposition Center meets requirements of the Americans with Disabilities Act. Accessible parking for individuals with limited mobility is located throughout the grounds. For ticketed events, call the KEC Ticket Office at (502) 367-5144. Tickets are subject to availability.

GENERAL INFORMATION AND SERVICES

FIRST AID

A first-aid room equipped with first-aid necessities will be maintained on the first floor of Freedom Hall near Ramp V and South Wing "C."

The Trailer located outside the West Hall is open 24 hours a day.

STATE POLICE

State Police are located at the end of the West Hall at the W8 door.

FEED AND BEDDING

Feed for livestock and horses may be brought in by exhibitors for their entries only or ordered from the official State Fair feed supplier. These orders shall be placed so that deliveries may be completed by 9:00 a.m. each morning.

TRASH AND WET GARBAGE

The Fair will provide large, portable containers for the disposal of manure and trash. These vehicles will always be parked at various locations throughout the livestock buildings. Wet garbage containers will be stationed at various places on Thrill Ville.

Golf carts may not be operated in Freedom Hall, Exposition Wings and Halls, or on the Thrill Ville between the hours of 9:00 a.m. to closing, unless written permission is given by President of the Kentucky State Fair Board. These hours will be honored for the 11 days of the Fair. All golf carts operated on grounds shall have a permit issued by the Kentucky State Fair, and users shall pay a processing fee on all golf carts (rented or owned). If you lose your golf cart permit, you should purchase another permit. If your golf cart is impounded, the golf cart will be held for 24 hours.

Kentucky State law requires drivers of motor vehicles to have a valid motor vehicle driver's license.

Bicycles, motorized scooters, skateboards, roller blades, hover boards, and skates are prohibited. Violators will have their equipment confiscated.

The owner/operator of the vehicle (including golf carts, city cars, and motor powered bikes) shall, on behalf of itself, its agents, servants, employees, customers, and guests hereby agrees to assume, defend at all times, indemnify, protect, save, and hold harmless the Kentucky State Fair Board and all its members, agents, servants, and employees against claims or demand arising or resulting from the use by the owner/operator of the vehicle operated on Kentucky Exposition Center premises. This includes, without limitation, the claims of any employee or agent of the owner/operator, the claims of anyone riding with the owner/operator of the vehicle and the claims of any person for damages for bodily injury, sickness, mental anguish, or death, and claims for damages to the property of any such employee, agent, or person. Kentucky State Fair Show Management shall not be liable for any loss, damage, or injury to the property of the owner/operator, which is sustained during use of the vehicle.

SHARPS CONTAINERS

Sharps containers will be in all barns and tents, and in the North Wing stalling area. Competition management shall place notice of this requirement in either the prize list or on a specific handout given to trainers on check-in at the competition.

Entries close Thursday, July 2, 2026

Late entry: July 3 — July 10, 2026 (an additional \$1,000.00 per entry)

There is only one closing date.

All entries must be postmarked or entered online on or before Thursday, July 2, 2026.
Postage meter date not accepted.

ENTRY BLANKS

One owner per entry blank. One check or credit card number per owner, which shall cover all charges. No entry will be put into the computer until all charges are paid. If a credit card or check is declined, you will be notified, and another shall be given that is solvent.

There will be a \$50.00 charge for all returned checks and for each declined credit card transaction or invalid credit card number.

The entry blank shall be complete in all aspects.

All horses and ponies shall be entered by their full names, including registration numbers, and in the names of the owners of record. Please include a current copy of the registration certificate; AHHS, and/or ARHPA membership cards; pony measurement card, if applicable; and Coggins.

All signature lines for the owner, rider, trainer, and responsible party (if applicable) shall be signed. The trainer may sign as an agent.

Entry blanks shall include a check or credit card number for the full amount to be processed for entry in the 2026 World's Championship Horse Show. Open checks will not be accepted for entries. We reserve the right to return checks and request that payment be made by cash or money order.

All Saddlebred horses and Hackney/Harness ponies shall be registered with the American Saddlebred Horse Breeders Association or American Hackney Horse Society by the closing date of Thursday, July 2, 2026.

All Roadster horses shall be registered with ARHPA, and those identification numbers provided.

AHHS membership numbers for owners and trainers shall be submitted and are also indicated on the membership cards, copies of which should be included with the entry form. ARHPA membership numbers for owner, driver, and trainer must be submitted.

The first 600 orders for VIP Parking will be completed.

All pleasure and park entries should be entered using a credit card, as it is easier to refund the entry fees if you do not qualify.

Futurity colts that do not qualify for the finals may enter the open class on Wednesday, August 26, 2026.

OPEN CHECKS

Entries postmarked after Friday, July 10, 2026, will not be accepted and will be returned. U.S. Postal Service postmark supersedes a postage meter date, but postmark will not be considered after Friday, July 10, 2026. No entries **RECEIVED IN THE OFFICE** after 5:00 p.m. (ET) on Friday, July 10, 2026, will not be accepted (regardless of postmark or meter date) and will be returned to the sender.

Entries will not be accepted without payment; they will be processed upon receipt of payment.

An open check or credit card shall be presented to charge championship entry fees, etc. Open checks and/or credit cards will be completed by the show office for the account within thirty (30) days after the closing of the show.

There will be a \$50.00 charge for returned checks and for each declined credit card transaction or invalid credit card number.

PREMIUM CHECKS

Premium checks will go to the payee only, who will also receive the 1099 tax form.

The Kentucky State Fair Board is a state agency; therefore, the premium checks cannot be issued without a Social Security number or Federal Tax Identification Number of the recipient. These shall be included on the entry blank. If a name is not specified for an entry, the premium money will be sent to the Owner of the entry.

Premium checks will be mailed 30 days from the last day of the show.

NOMINATION & CHAMPIONSHIP FEES

For your entry to be listed in the championship class in the program, you shall enter the original entry blank and pay the nomination fee.

The nomination fee is non-refundable.

The remainder of the championship fee will be paid upon entering the class.

For those not nominated for a championship who are entering championships at the show, the following post entry fee will be charged, plus the regular entry fee Championship - \$55.00; Equitation Championship - \$25.00; World's Grand Championship - \$250.00.

Entry fees will be charged to ribbon winners only in all seven (7) of the World's Grand Championship classes (Five-Gaited, Three-Gaited, Fine Harness, Road Horse, Road Pony, Harness Pony, and Hackney Pony).

Declarations for showing in all World's Grand Championship classes are to be made **Thursday, August 27, 2026, at 3:00 p.m.**

The first three (3) winners in the open qualifying classes shall show back in their respective World's Grand Champion class or forfeit their winnings in the qualifying class. In the three (3) Five-Gaited qualifiers, the first two (2) winners shall show back in the World's Grand Champion class or forfeit their winnings.

Draws for In-Hand classes will be posted no earlier than one (1) hour before the session. Equitation patterns will be available on the website two (2) weeks before the start of the show.

FOOTING

The footing is a clay base with sawdust; the dimensions of the ring are 117' x 290'.

RIDER-DRIVER AGE

All classes divided by Rider/Driver age will be determined by age as of December 1, 2025.

PONY MEASUREMENT

Numbers will not be issued without a measurement card.

If your pony shall be measured, please come to the office, and get a measurement form.

Measurement of ponies will take place Saturday, August 22, 2026, at 9:00 a.m. or Sunday, August 23, 2026, at 9:00 a.m. at the entrance of the North Wing.

If your pony cannot be measured at either of the above times, please arrange a measurement time for your pony in the office or with the stewards.

CHANGES

No changing or adding entries for qualifying classes will be allowed after Friday, August 22, 2026, at 2:00 p.m.

The fee for changing qualifying classes will be \$25.00, plus the original entry fee.

After the final closing date of Thursday, July 2, 2026, an Equitation horse may not be entered into a Performance class, nor may a rider of a Performance horse be entered into an Equitation class.

No substitutions for Performance classes will be allowed.

If an Equitation horse becomes unable to show, a substitution will be permitted, providing the office has been notified of the horse being used.

When changing division divided by height, the horse must be measured at the horse show.

IMPORTANT: Should a trainer, exhibitor, or owner need to request to be in a specific split or division of a class, they must come to the office and fill out a request form by 2:00 p.m. on Friday, August 21, 2026. After that time, no requests or changes will be made to splits and divisions. While requests are made, they are not promised!

SCRATCHES

Scratches from a class must be made as listed:

- By 5:00 p.m. the night before the morning's sessions
- By 1:00 p.m. the afternoon of the night session

A fee of \$100.00 per horse, per class will be charged upon failure to scratch the session before the class.

If the classes are split and then scratch down, the manager has the option to combine the splits and run one class up to approximately one hour prior to the start of the class.

Only the stall fee will be refunded on a scratched horse. Entry fees, badges, etc. WILL NOT be refunded.

Owners/Trainers of horses entered and scratched will be charged a non-showing fee of \$1,000.00 when the stall is not returned to management.

Scratches from a morning sessions class must be made by 5:00 p.m. the night before: night session classes are to be scratched by 1:00 p.m. the afternoon of the night session.

Any entry in a class that is split and does not show in the class will be charged a penalty fee of \$600.00, even if the horse is scratched that morning or afternoon of the class.

REFUNDS

Veterinary certificates for entry fee reimbursement will not be accepted.

All requests for refund corrections on payee statement shall be made in writing by Friday, September 11, 2026.

If entries are made by credit card, refunds will be made within a two-week or fourteen (14) day period.

It is strongly encouraged that Pleasure and Park entries be made with a credit card in case the entry shall be returned due to not being qualified.

STALLS

For a refund on a stall returned to management, the correct number of stalls used must be given to the office on or before *Monday, July 27, 2026*. No credit will be given for notification after this deadline.

Exchange of stalls must be made through the office and approved by the manager.

Due to limited facilities, only horses showing at the 2026 Kentucky State Fair are to be stabled on the grounds.

Owners/Trainers of horses entered and not shown will be charged a non-showing fee of \$1,000.00 if the stall is not returned to management.

Horses will not be stabled until Tuesday, August 18, 2026, without prior arrangement with management. Do not bed at stalls before this date.

No first bedding provided for stalls. Doors are on all permanent and portable stalls.

The State Fire Marshall requires 2A10BC fire extinguishers and smoke detectors for all stalls used as living quarters during the World's Championship Horse Show.

FEED, STRAW, SHAVINGS AND HAY

Feed for livestock and horses may be brought in by exhibitors for their entries only or may be ordered from the official State Fair feed supplier. These orders shall be placed so that deliveries may be completed by 9:00 a.m. each morning. (see page 30 for contact Information for the official feed supplier.)

TRANSFER OF A HORSE

A horse entered by the closing date that is sold may be transferred to the new trainer, but all entry and stall fees will remain with the original entry blank, and/or the person who originally made the entry.

A change of owner and/or trainer shall be accompanied by a credit card number, if original fees are to be transferred with the horse. The office shall be notified in writing by the original owner or trainer.

VETERINARIAN

The Kentucky State Fair will have an official veterinarian on the grounds. He/she or an assistant will always be available, and they may be reached when the show is not in progress.

During the show, please contact the Horse Show Office (502) 367-5300, or the number posted on the doors of the Horse Show Office.

HEALTH REQUIREMENTS FOR HORSES

WL707 Equine Biosecurity Guidelines - Local, State, or governing officials may have specific recommendations based on current infectious disease trends for a specific area.

ESC requires that all equine arrivals on the show grounds have current vet certificates (CVI) and vaccination records. Non-compliance to required certificates are subject to Class 1 violations and not permitted on the show grounds.

DOGS

Dogs must be confined to the stable or tack room area and must be kept tied or on a leash or crated. No dogs are allowed in the Freedom Hall or Horse Show Office.

MAKE-UP RING

The number of people with a horse in the make-up ring before an under-saddle class will be limited to three (3), and for a harness class four (4). This is to ensure the safety of everyone involved. All others involved with horses should stay behind concrete barriers, including personal photographers.

An area for Publication Photographers will be provided in the make-up area, and all pictures shall be taken there. No private or personal photographers shall be in the make-up ring.

Kentucky State law requires drivers of motor vehicles to have a valid motor vehicle driver's license.

The above applies to Championship classes that are for ribbon winners only. If no Open qualifying classes are split, those qualifying may show back in the championship, but management may limit the number to ribbon winners only.

If a situation arises that is not covered in the above policies, then management will determine the eligible ribbon winners, and they will be posted in the horse show office.

When classes are divided, horses shall stay in the class shown in the program or as posted.

Exhibitors are not allowed to choose their class. This is entirely the decision of management.

Trainers are responsible for checking class splits.

If the classes are split and then scratch down, the manager has the option to combine the splits and run one class up to approximately one hour prior to the start of the class.

A class with divisions will be run as one class if there are fewer than 20 entries.

KENTUCKY COUNTY FAIR CHAMPIONSHIPS

All horses in the Kentucky County Fair Three-Gaited, Fine Harness, and Five-Gaited classes shall be registered American Saddlebreds, and ponies in the Hackney and Harness Pony classes shall be registered Hackney Ponies.

Five-Gaited, Three-Gaited, Road Horse and Road Pony – Must show in eight (8) classes within five (5) horse shows of the same section that are member shows of the Kentucky Association of Fairs & Horse Shows.

Harness & Hackney Pony & American Saddlebred Fine Harness—Must show in five (5) classes at five (5) horse shows at the same section that are member shows of the Kentucky Association of Fairs & Horse Shows.

False representation of eligibility will cause disqualification in the 2027 Kentucky State Fair's World Championship Horse Show.

Owners must be members of the association. The membership fee is \$100.00 and may be sent to: Kentucky Association of Fairs & Horse Shows, PO Box 25, Greensburg, KY 42743. If not a member at time of entry, the membership fee will be charged to your account.

The qualifying period begins the day following the 2025 Kentucky State Fair World's Championship Horse Show and continues until the day beginning the 2026 Kentucky State Fair World's Championship Horse Show.

Road Horses or Pony Under Saddle and Road Youth classes are not qualifying classes.

MISCELLANEOUS

Any class at the 2026 Kentucky State Fair World's Championship Horse Show that has fewer than five (5) horses shown will be put on probation in 2027. If fewer than five (5) horses are shown in 2027, the class will either not be held or combined with a class that has the same specifications in 2027 or 2028.

The Kentucky State Fair reserves the right to decline or accept any entry or entries, and to return or decline refunds of any fees.

False representation of eligibility or information will cause disqualification and may result in you or your horse not being allowed to show in the 2027 Kentucky State Fair World's Championship Horse Show.

The Kentucky State Fair may also prohibit any person from attending or showing a horse in the ring and remove any owner, stable employee, or horse from the ring or grounds without liability of any kind.

The lights in the North Wing will turn down each night starting Thursday, August 20 at 1:00 a.m.

Commercial Exhibitors/Solicitors will not be allowed on the grounds unless a commercial exhibit booth space is purchased. Any exhibitor who sells out of their stalls will be charged a commercial exhibitor fee.

An entry shall be ready 20 minutes before the class in which it is entered is called. Progress of the preceding class will be announced over the speakers in the stable area. Failure to hear the announcement shall not relieve the exhibitor of the obligation to have entries ready and to comply with the rule. Barn calls are a courtesy of the show. Every effort will be made to maintain a working public address system to carry class calls. Due to the

schedule and time, a request for a hold between classes cannot be made

Any exhibitor, rider, or driver who refuses to obey the request of the judge, ringmaster, or manager automatically becomes debarred from further competition and forfeits all previous winnings, together with entry fee and other charges. At the discretion of the manager, the offending individual and his/her entire exhibit may be removed from the grounds.

All electrical equipment, regardless of source of power, must comply with all national, state, and local safety codes. All electrical cords shall be the 3-wire grounded type. All exposed noncurrent-carrying metal parts of fixed equipment, which are liable to be energized, shall be grounded.

Individuals stabled in Barn A-O facing the west and those stabled in the North Wing facing the north aisle are asked to not dismantle their stall decorations until the conclusion of the show on Saturday night. Failure to do this may result in you being stable in another location for next year.

Individuals wishing to leave shall load before and after the show in the morning/afternoon session and the night session. You will not be allowed to load your equipment and horses during the show, as a courtesy to the people still showing.

Parents: If not accompanying your child, please send permission for medical treatment (responsibility for care) with the trainer or responsible adult.

WORK AREA

All horse vans or trailers should enter via Gate 6 off Preston Highway.

Freedom Hall, Stopher Walk, the Make-Up Ring, and Outside Arenas are monitored by security cameras.

The Covered Arena and work arena in the tent area will be closed to working fifteen (15) minutes before each session until the session is over. The covered arena is used for warm-up by many in preparation for showing. It will open for use after each session of the show is finished.

Stopher Walk – Available up to 30 minutes before show time. During the show, it is available only to horses preparing to show in the next class.

Saturday night, August 22, 2026, after the performance, the first hour in Freedom Hall, no whips, noisemakers, or attention getting devices will be allowed.				
Monday through Friday, the first hour after the afternoon performances, will also be work time without attention getting devices. A steward will be in the center ring during this time to enforce this policy. On Saturday afternoon, Freedom Hall will be closed to everyone.				

No beverages are allowed around the rail at any time during the show. The red-taped area on the straightaway is for trainers and grooms with horses in that class.

ILLEGAL EQUIPMENT/PRACTICES

Attention-Getting Devices - Devices used to arouse attention from a horse (excluding proper use of a whip) are prohibited during warm-up and show sessions. Such devices include but are not limited to laser/strobe lights, tape measures, firecrackers, fire extinguishers, sirens, horns, and other noise making devices.

In consideration of your fellow exhibitors and for presenting the proper image of the American Saddlebred, attention-getting devices should be used with caution in the warm-up and schooling areas. We encourage you not to use lash whips on victory passes.

DRESS CODE

The UPHA has adopted a dress code and has requested it be put into effect at the Kentucky State Fair World's Championship Horse Show; it is as follows and applies to all trainers, handlers, grooms, and other participants entering the show ring:

- Collared shirts required. Stable names and logos are acceptable.
- Shirts must be tucked in while in the show ring.
- Slacks or Khaki pants only (no denim or shorts).
- Billed hats must be worn forward.

KENTUCKY STATE FAIR WORLD'S CHAMPIONSHIP HORSE SHOW 2026 QUALIFYING REQUIREMENTS FOR PLEASURE (SHOW & COUNTRY) AND PARK

Any competition that has not previously been listed on the database shall record at least one (1) month prior to the competition dates to be a qualifying competition for the World's Championship Horse Show. The prize list and/or schedule must be submitted one (1) month prior to the first date of the show, either electronically or physically.

1. All horses shall qualify to compete in the American Saddlebred Show Pleasure, American Saddlebred Country Pleasure, and American Saddlebred Park Divisions of the 2026 Kentucky State Fair World's Championship Horse Show.

Horses will be entered in these Divisions only if they have been shown in a minimum of six (6) classes, in three (3) or more different competitions, (not including the 2025 World's Championship Horse Show) in the same Divisions in which they wish to compete at the 2026 World's Championship Horse Show, either under saddle or in harness, beginning July 1, 2025, through June 30, 2026. At the 2026 World's Championship Horse Show, the same horse may not enter and/or compete in the Junior Exhibitor and the Adult class, nor may it enter and/or compete in "under saddle, driving, western, and hunter" or in more than one age division.

Horses that are to be shown in Pleasure Driving will be required to qualify by showing in six (6) classes at three (3) shows in Pleasure Driving. If the Driving class at a show does not specify whether it is Show or Country Pleasure, the class will still count, but four (4) of the six (6) classes for qualification must be in either Show or Country Pleasure. Park Pleasure driving, and Open Pleasure driving classes will not be considered as qualifying classes.

Classes and points earned in a division, such as Three-Gaited Show Pleasure, cannot be applied to another division, such as Five-Gaited Show Pleasure, nor can classes and points in Western Country Pleasure, Saddle seat Three-Gaited Country Pleasure, or Hunter Country Pleasure be applied to any other Country Pleasure division. This does not affect or change the rule that a horse can show in juvenile, adult, novice, or local, or limit classes in a division for the points and classes to count toward qualification.

Also for purposes of qualification, a horse in the Show Pleasure or Country Pleasure Divisions cannot be shown by its trainer on behalf of the owner of the horse, nor may a horse be shown by any adult family member of the trainer of the horse (provided, however, that this does not preclude a family member of a trainer from showing a horse if the horse is owned by the trainer or by such family member).

For purposes of potential Show Pleasure, Country Pleasure, and Park qualifying for the 2026 Kentucky State Fair, points will not be accumulated at the Kentucky State Fair by horses competing in the 2025 Kentucky State Fair; performances at the 2025 Kentucky State Fair will be excluded from potential qualifying point totals for the 2026 competition.

Effective for the 2026 World's Championship Horse Show, any class added to a show's schedule after the prize list, class sheet, or class schedule has been printed and/or posted on the show's website, Facebook

page, etc. will not count as a qualifying class for Kentucky State Fair's World's Championship Horse Show. Classes denoted as "buy a class" or "TBA" are considered added classes and therefore will not be counted. Classes that are added during the week that a horse show is scheduled to be held do not count as qualifying.

2. Qualifying information for the American Saddlebred Show Pleasure, Country Pleasure, and Park Division is on page 25-27 of the 2026 Horse Show Premium Book.
3. Each qualifying class in the American Saddlebred Show Pleasure Horse Division, the American Saddlebred Country Pleasure Horse Division, and the American Saddlebred Three-Gaited Park Division has a maximum number of qualified entrants that will be permitted to compete in each class.

4. In the event that the total number of entrants received for any qualifying class does not exceed the maximum numbers listed in #3 above, all entrants will be permitted to compete at the 2026 World's Championship Horse Show.
5. As in prior years, Championship classes at the 2026 Horse Show will be limited to competitors who have received a ribbon in a qualifying class at the 2026 Horse Show. In the case of a split of a qualifying class, the policy for divided classes explained on page 22 of the prize list will be applied.
6. In the event that the total number of qualified entrants received for any qualifying class exceeds the maximum numbers listed in #3 above by five (5) horses or less, the Kentucky State Fair reserves the right to permit all qualified entrants to compete in a qualifying class, but if the number entered exceeds the maximum number by more than five (5), the number of entries will be reduced to the original maximum number (e.g., if there are 66 entries in Adult Show Pleasure, only 60 will be allowed to show). The horses that will be eligible to compete in such qualifying class will be chosen based on a point system tabulated.
 - Show Pleasure, Country Pleasure, and Park horses must have "qualified" as described in #1 above six (6) classes, at three (3) shows, in the same Division.
 - **Effective 2015**, qualifying (i.e., six (6) classes at three (3) shows) is no longer required for Junior Park and Junior Park Pleasure horses.
 - All American Saddlebred horses competing in any competition listed on the database, regardless of whether such competition is a licensed competition, will be eligible for consideration. For non-licensed competition to be listed on the database, a representative of that competition shall notify the dates, location, and contact information for the person in the competition at least one month before the competition is to be held. The secretary or the manager of said competition is responsible for sending in the results within ten (10) days after the competition and by the closing date of the qualifying period. Results will not be accepted (regardless of the postmark or meter date) that are received in the office after the closing date of the qualifying period.

- **Effective 2016** — Any competition that has not previously been listed on the database shall register at least 30 days (one month) prior to the competition dates to be a qualifying competition of the World's Championship Horse Show.
 - All ribbon winners in classes of eight (8) or more entries will receive the following points - 8, 7, 6, 5, 4, 3, 2, 1 (8 for 1st, 7 for 2nd, and so on) based on number of ribbons awarded; a class with five (5) entries from first place through fifth place, as follows: 5, 4, 3, 2, 1; a class with four (4) entries, from first place through fourth place as follows: 4, 3, 2, 1; a class with three (3) entries, from first place through third place as follows: 3, 2, 1; and a class with two (2) entries, the first place through second place as follows: 2, 1. A class with one (1) entry will receive one (1) point. Points will count in the following Divisions: Show Pleasure Three-Gaited, Five-Gaited, and Driving Country Pleasure Three-Gaited, Western, Hunter, Five-Gaited and Driving; and Park — Three- Gaited. Walk/Trot 12 & under. Points will not be allocated in the following classes for qualification at the 2026 Kentucky State Fair: Open Pleasure, Walk/Trot Pleasure (over 12 years old), English Pleasure, Saddle Seat Pleasure Open to All Breeds and Opportunity, "Buy A Class" TBA, or classes built into schedule that may be purchased will not count, or any class other than Park that the horse can be shown by a professional.
 - Points will not be allocated in Show Pleasure, Country Pleasure, and Park Division (as noted in #1) at the 2026 Kentucky State Fair.
 - To break any tie necessary to determine the eligibility list, preference will be given to the entry with the larger number of points earned from classes with six (6) or more entries will be given preference.
 - Only points accumulated during the qualifying period in the Division in which the horse is entered at the 2026 Kentucky State Fair will count toward qualifying for the Kentucky State Fair. Points accumulated during the qualifying period remain with a horse, regardless of any change(s) of ownership.
 - Points accumulated by each horse will be posted on the website. The results for competitions that are listed on the website will be used to determine points for eligibility and shall be in the office for tabulation by the end of the qualifying period (regardless of postmark and metered date). The Kentucky State Fair reserves the right to resolve any dispute as to the accuracy of the point total used to determine which horses are deemed eligible to compete.
 - The first and second place winners only (i.e., Champion and Reserve Champion) in a championship class for Show Pleasure — Three-Gaited, Five-Gaited, and Driving; Country Pleasure — Three-Gaited, Five-Gaited, Western, Hunter and Driving; Park—Three-Gaited, Walk/Trot 12 & under at the 2026 World's Championship Horse Show shall be eligible to compete in the same Division in 2026 for which the championship class was held, provided that such horses also showed in a minimum of six (6) classes, in three (3) or more different competitions (not including the 2025 World's Championship Horse Show), in the same Division in which they wish to compete at the 2026 World's Championship Horse Show, either under saddle or in harness during the period beginning July 1, 2025 and ending June 30, 2026.
7. The Kentucky State Fair World's Championship Horse Show reserves the right to exclude a class that does not qualify as an American Saddlebred competition, such as any of the following:
- "Open English Pleasure"; "Open Western Pleasure"; "Open Hunter"; "Pleasure Prospect"; "Open to All Breeds", Opportunity classes, "Buy A Class"; TBA or classes built into a schedule that may be purchased; Park Pleasure will not count not any class other than Park Division classes in which a professional trainer is permitted to show a horse.
8. The Kentucky State Fair World's Championship Horse Show reserves for itself, without limitation, the sole and unconditional right to interpret any questions or disputes regarding the interpretation of the above, including any ancillary questions, without further recourse, and its decision shall be final.

2026 TROPHY POLICY

Perpetual and challenge trophies will remain with the horse show, as they will no longer be checked out to the exhibitor for a year.

STALL ENTRY LIMITATIONS

Stabling capacity at the Kentucky State Fair World's Championship Horse Show has reached its limit over the past several years. No additional temporary stabling can be built beyond the capacity of previous years. Therefore, while it is extremely unlikely, it is conceivable that an insufficiency in stabling capacity and/or consequent available time in the schedule may result in Management determining that a division or section of the Kentucky State Fair World's Championship Horse Show is deemed to be overfilled. If Management deems that any division or section is overfilled, the Kentucky State Fair World's Championship Horse Show reserves to itself the right to determine the number of entries in that division or section, based on winnings in the qualifying period of July 1, 2025, to June 30, 2026.

If qualifying standards are invoked by the management of the Kentucky State Fair World's Championship Horse Show, and if the number of horses competing in Recognized Competitions is insufficient to fill all space and stabling is available, all other horses entered (those horses having no points) will be placed in a separate pool. If necessary, a lottery drawing will then be conducted from this pool to determine the entries to be accepted. The number of horses to be selected by means of this drawing will be determined at the time of any decision to refuse entries. Whether a division or section is overfilled and the extent to which it is overfilled, shall be determined at the sole discretion of the Kentucky State Fair World's Championship Horse Show.

In the event of a tie in total points affecting the standard required for entry acceptance, a drawing will be held among all those with identical points to determine which entries will be accepted and/or refused.

Entries will enter the ring one at a time showing at a trot, to be led down the right-hand rail to the other end of the ring and return to the judges at a trot and then be judged standing on conformation. On the return lead, entries are permitted to trot past the judges to the end of the ring, if so desired, and then return to the judges. Entry will then be led to the opposite rail at a walk, out of the way of subsequent entries. If judged on conformation a second time, entries must again be led at a walk and trot. Entries are not to be judged lunging. A diagram will be posted in the horse show office. A second workout in a large class is strongly encouraged at the judges' discretion.

Conformation and finish count 50% of the total score. All entries shall be judged according to the standards for the ideal American Saddlebred type and conformation. Undesirable traits shall be penalized.

If a final is held, the Weanlings will be the first class on Monday Night, and the Yearlings will be the first class on Tuesday Night.

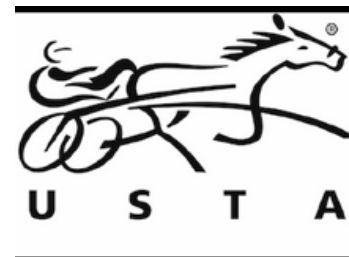

Class Requirements:

1. Horses must be 100% Standardbred and registered with USTA or Canadian Trotting Association/Standardbred Canada. Horses registered as Pleasure are eligible to compete as long as they are 100% Standardbred. Registration will be checked at Louisville prior to showing. Copy of papers and ARHPA HorseID certificate must accompany entries, and ownership must be both current and correct.
2. Horse cannot have shown in any roadster class prior to August 28, 2024, with the following exception: non-winning horses that competed in the 2024 USTA Roadster Classic. Horse must show in two (2) classes prior to the WCHS in order to be eligible.
3. All horses that qualify for the Final must show and be judged in the Final class held on Thursday night at the WCHS to be eligible to compete for the following year's USTA Roadster Classic. Horses excused from the final class by either judge or a competitor are NOT eligible for the following year's USTA Roadster Classic.
4. Owner, Trainer, and Exhibitor must all be current members of the ARHPA and USTA.
5. Tattoo or freeze brand will be checked before entering the ring.

Directions to the Kentucky Exposition Center

From I-65 Northbound

Exit at the Fair/Expo Center (Exit 131 B) and follow the signs to Gate 1, the main entrance.

From I-65 Southbound

Exit 132 to Crittenden Drive and merge to the far left; turn left at the first stoplight. Gate 4 to the Fair/Expo Center will be directly on the left, past the Cracker Barrel restaurant. 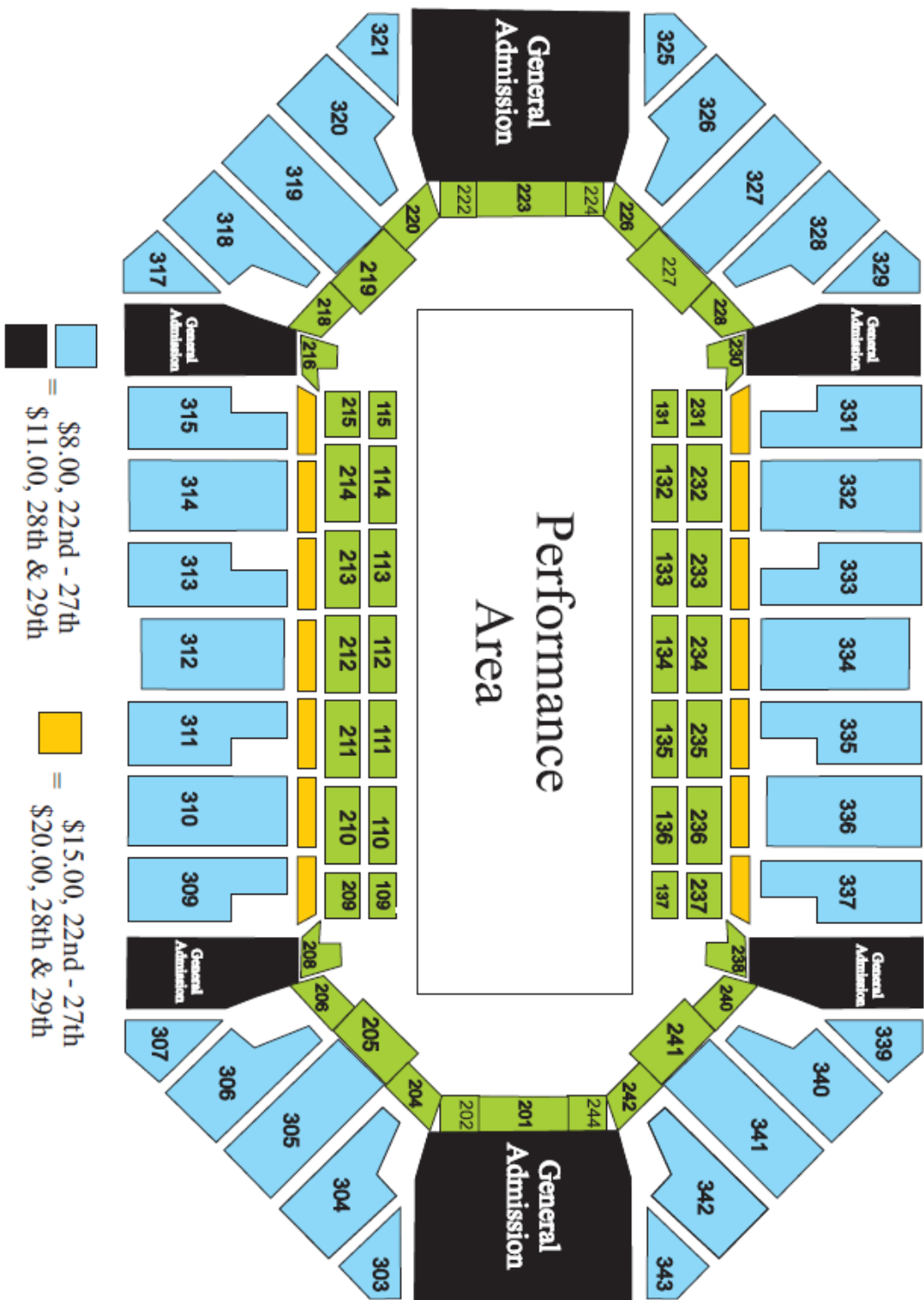
